SAMPLING: Samples for determination of physical and chemical properties of the goods were drawn during the whole course of loading according to GAFTA Rules. At the end of sampling sub-lot samples were mixed well, divided and final samples were prepared. All samples were sealed by our surveyors.

QUALITY: One set of samples was expedited to GAFTA/FOSFA approved Laboratory in KHERSON/UKRAINE for analysis. We certify that the commodity is conformity with the following quality specifications.
